**Release for Minor Disc Jockeys**

In consideration for Nichols College's allowing my SON/DAUGHTER/ENTRUSTED MINOR (the "trustee") to participate in the NICHOLS COLLEGE RADIO STATION/LIVE RADIO BROADCAST (the "Activity"), I hereby forever remise, release, acquit, discharge, covenant not to sue and covenant to hold harmless Nichols College, its trustees, officers, directors, principals, attorneys, faculty, employees, agents, representatives, subsidiaries, affiliates, predecessors, successors and assigns (collectively, the "Released Parties") from any and all actions, causes of action, liabilities, claims, damages, costs, expenses, injuries (personal or otherwise) and losses whatsoever of every name and nature, both in law and in equity, known or unknown, that my trustee has or may hereafter acquire arising out of or related in any way to their participation in the Activity including, but not limited to, any and all claims and injuries, personal or otherwise, arising from, related to or connected with any negligent act by any of the Released Parties and any and all claims and injuries, personal or otherwise, attributable in whole or in part to their participation in the Activity, including traveling to, training for, being coached in, using equipment for or participating in the Activity. I further agree to indemnify and hold harmless the Released Parties from and against all actions, causes of action, liabilities, claims, damages, costs and expenses (including, but not limited to attorneys' fees), injuries (personal or otherwise), and losses whatsoever in any way, in law or equity, arising out of or related to my trustee's participation in the Activity.

I recognize that there are risks and hazards that may, directly or inherently, be involved in this Activity with the potential to cause injury. My SON/DAUGHTER/ENTRUSTED MINOR does not have any physical limitations, medical ailments or physical or mental disabilities that would limit or prevent them from participating in the Activity, and, if required they will obtain a medical examination and clearance prior to participating in the Activity. I acknowledge that I have had the opportunity to ask any and all questions related to the Activity and to this Release from Liability/Covenant Not to Sue and with full knowledge of the facts and circumstances surrounding the Activity agree to all the terms contained herein.

I understand that the radio program my SON/DAUGHTER/ENTRUSTED MINOR participates in may be recorded. I give Nichols College permission to air this recording and/or use it for promotion of the radio station without additional notification/consent.

I further understand that Nichols College is not responsible for and does not assume liability for my SON/DAUGHTER/ENTRUSTED MINOR'S actions while participating in the Activity and that Nichols College does not have, and will not have, any obligation to pay me or to reimburse me for any legal fees that I might incur as a result of my trustee's actions in connection with the Activity.

**Age Requirement for Disc Jockeys/On-Air Guests**

Due to the public forum the radio airwaves provide, and to protect the privacy of underage individuals, it is the policy of WNRC and Nichols College that all disc jockeys and on-air guests must be over the age of 18. Disc jockeys and on-air guests who are under the age of 18 must have a signed consent form from a parent or guardian before they will be allowed to speak on the air. An exception to this policy will be made for current Nichols College students who have yet to turn 18.

Blank consent forms will be available in the radio station. Signed consent forms will be kept on file in the station.
